

Mission and Purposes of ICAIA

The Illinois College Automotive Instructors Association (identified as ICAIA) is dedicated to providing comprehensive automotive technology education and training for its membership on a semi-annual basis

Its members shall consist of both secondary and post-secondary automotive technology instructors, individuals whose livelihood is directly related to the automotive industry, and students who are pursuing a career in automotive service and repair. (Even though the association has Illinois in its name, individuals residing in surrounding states are encouraged to become members).

ICAIA will support state and national organizations that can aid in the betterment of Vocational and Technical Education, especially those that support programs that prepare individuals for careers in the automotive service industry.

The following purposes are of equal importance in realizing the mission of the ICAIA:

- ?? To provide automotive instructors with current technical information semi-annually
- ?? To utilize technical seminars, equipment displays, and training aids to further upgrade automotive technology instructors.
- ?? To allow networking and interactions between professional colleagues and individuals from industry during ICAIA conferences.
- ?? To provide up-to-date technical automotive career education that meets the needs of students, business, and industry.
- ?? To award scholarships to automotive technology students as directed by the ICAIA Board of Directors.

NATEF training hours and State of Illinois Continuing Professional Development Unit (CPDU) Credits

The Illinois College Automotive Instructors Association is approved by the Illinois State Board of Education to issue CPDU Credits. Technical training hours can also be counted towards the NATEF instructor training requirement for certified programs. Please review the following so that conference attendees receive all of the CPDU or NATEF credits entitled.

- En order to receive credit for attending a technical seminar, you will be required to turn in a seminar evaluation form at the end of each seminar/session. 9 CPDU credits or training hours can be earned by attending 5 of the training sessions and the Thursday evening banquet and presentation.
- The seminar evaluation forms will be in your conference folder, along with labels pre-printed with your name (providing you pre-register). Walk-ins will have to PRINT (legibly) their names on the evaluation forms.
- At the conclusion of the seminar/session, fill out the evaluation form, stick a label with your name on it, and turn in the evaluation (right in the seminar room).
- An ICAIA Officer or Board Member will collect the forms from the seminar room after each seminar/session and bring turn them into Art Koudelka, ICAIA Executive Treasurer/Secretary.
- Zelf you do not turn in an evaluation form with your name on it, you were never there. No CPDU Credits/Training hours will be given.
- Everyone attending the seminar/session should complete an evaluation form with their name on it. ICAIA will be printing and mailing certificates to all conference attendees listing the seminars they attended and granting them CPDU's or Training Hours.

Illinois Automotive Profile

The automotive industry plays a large part of the economic engine in the State of Illinois. If we were to take a look at just one facet of the industry, that being the new-vehicle dealerships, one can visualize the impact these businesses play in both their local community and State economies. Of the 21,650 new-vehicle dealerships in the US, Illinois is home to 1,027 of them. These 1,027 dealerships represent just 3.5% of the total number of retail establishments in the State. In 2003, they recorded \$27.991 billion in total sales, making the average Illinois new-vehicle dealer generating \$27.255 million in sales. Impressive numbers when one considers that this represents 21.6% of all retail sales dollars in the State of Illinois from just 3.5% of the total retail establishments.

The estimated number of new-vehicle dealership employees in the State is 46,191, which is 9.1% of the total retail employment in the State with a total of approximately \$2.09 billion in annual payroll. This annual payroll makes up 12.8% of the total retail payroll in the State from just 9.1% of retail employment.

The average dealership in Illinois has 45 employees, \$2.03 million in annual payroll with the average employee weekly earnings of \$874. Capital that is invested back into the local and State economy. For automotive service technicians in the State of Illinois, data show that the entry annual salary is \$19,920, the median annual salary is \$30,573, and experienced annual salary is \$42,314.

This economic engine will continue as the US is approaching 226 million vehicles in operation. In the past 6 years, the total light-vehicle fleet has increased by an average of 2% every year. In 2003 the median age for the car population was 8.6 years (up from 8.4 in 2002) and light trucks 6.5 years (down from 6.6 in 2002 primarily because of increasing sales numbers). In 2003 it is estimated that the average light vehicle on the road is 7.8 years old (down slightly from 7.9 in 2002). Great numbers for those considering the amount of repair and maintenance work to keep these vehicles rolling.

It is estimated that the total numbers of vehicles in operation in the State of Illinois are as follows:

6,099,582 passenger cars 3,459,649 trucks and buses 9,577,222 total vehicles

Statewide employment for automotive technicians in 2000 was 35,937 with an expected 41,661 by 2010, a 15.93% increase. Considering that if total vehicle population in the State does not increase as it has in the past and stays constant, by 2010, that makes 229.8 vehicles per technician.

I hope that this information assists automotive instructors in expressing to administrators, guidance counselors, students and their parents just one part of the vast automotive industry and the part it plays in both the local and overall State economy.
